ORDAINS:

**SECTION I
AMENDMENT OF ARTICLE 8, SECTION 8.1(4)(c) PARKING OF MOTOR VEHICLES**

Article 8, Section 8.1(4)c of the Alamo Township Zoning Ordinance, Parking of Motor Vehicles, is hereby amended to read as follows:

Section 8.1 – Parking of Motor Vehicles:

(4) Minimum Required Parking Spaces:

c. Retail Stores, Super Markets, Department Stores, Personal Service Shops, and Shopping Centers - One parking space for each 300 square feet of gross floor space.

**SECTION II
SEVERABILITY**

Should any provision or part of the within this Ordinance be declared by any Court of competent jurisdiction to be invalid or unenforceable, the same shall not affect the enforceability of the balance of this Ordinance which shall remain in full force and effect.

**SECTION IV
REPEAL**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V
EFFECTIVE DATE

This Ordinance shall take effect eight days following publication after adoption.
